




#### **Project Goal**

### **Analysis**


- Qualitative data analysis

JE: I see okay. Next question is if you feel like your val- Yup'ik values, knowledge, wisdom that you learned growing up. Is that reflected in Fisheries today?

AM: No its definitely not. It feels like more of a commercial fishery now and not an experience cause fishing is more, people aren't really mad that they aren't catching fish they are, a lot of it is doing to the experience of fishing. It's not they can get fish at any time but telling people you cant fish really hurts knowing that you can't do something that you've always done and so and Yup'ik people as a whole are trying to constantly be busy so. Not for weeks on end not doing anything really, really, messes up. Messes up a lot of people.



#### Indigenous Stewardship Practices & Values

"Our ancestors were always being respectful of the fish they caught and they did not overtake...we're sharing peoples...there's a lot of stories about sharing, especially with those who are less fortunate."

"My mom taught me really young how to take care of food on hand right away...seals, furs, salmon, anything...She taught me a lot...now I teach my grandkids even when they're young..."

## Indigenous Stewardship & Care

- Fishing "terminal areas"
- Release large female salmon
- Salmon processing timing
- Following guidance of Elders or Chiefs





#### **Concerns for Salmon and Communities**

"I didn't get any silvers because these places where I was fishing before are...dying...the water is not clear like it used to be...it's dead waters...the fish I got out of there were sad and weak." – Project Participant

"I think the world we are living in right now is so busy and so modern and technology, we are forgetting these things, even though these unwritten rules and traditions, they are still very important to our identity..." - Megan Leary

"That's the biggest worry I have...is we aren't teaching anybody nothing, we are not teaching Yup'ik values, we are teaching that we have to fight for fish to be able to fish."



Everything that affects the fish, the people...has to be involved and in place and part of the management."

## Salmon, People & the Future



"Oh my. I would love for them to be sitting on the bank in their fish camp with you know getting enough fish for their needs for that year without wasting or overdoing. You know there's, I would love for them to have that, to having their babies running on the beach and fishing on the rest of the week, you know. ""I got a whitefish gram"" and they would run it up the bank and show me and then I would have to go down the bank and scale it and cut it up and hang it in the smokehouse. I would love for them to get that experience and the closeness of being together, gathering their food for the winter as a family." - Betty Simeon
